Assets can be grouped by type with default depreciation rates, depreciation codes and asset codes for reconciliation with the general ledger.

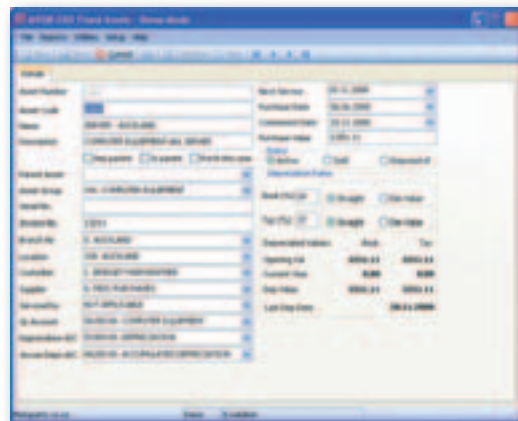
Purchasing new assets

Asset manager is fully integrated with your purchasing function in MYOB EXO Finance.

For any new asset purchase you will be prompted when viewing your existing assets of the new purchase and have the option to create the new fixed asset.

Depreciation

MYOB EXO Fixed Assets tracks both book and tax values for up to seven years. Completely integrated with MYOB EXO Finance, depreciation can be calculated and posted to the general ledger quickly and easily.



Asset movements

Asset locations are chosen from a drop down menu and can easily be relocated within the system. You can also update the general ledger whenever assets are re valued or sold and have access to a full history of these changes.

Parent/child assets

Manage related assets by creating a link that assigns one asset to another. This makes it considerably easier to track down components that are part of a larger asset.

Maintenance tracking & reporting

Allows the user to track maintenance requirements for assets by setting service dates for individual assets. Regular reporting allows you visibility of upcoming maintenance.

Reporting

Reports are provided for Asset Groups, Depreciation, and Revaluation and Maintenance. All reporting is managed from the Clarity Report Writer providing the same reporting power and flexibility as within MYOB EXO Finance.

Extra fields

MYOB EXO Fixed Assets powerful Extra Fields feature can be used to capture important information that is specific to the assets in your business.

Integration to your general ledger

MYOB EXO Fixed Assets is integrated to the General ledger in MYOB EXO Finance. Purchases made in the GL using the Assets GL codes are flagged in MYOB EXO Fixed Assets for recording.
